Welcome everyone and thanks for your time and interest in Liberation Larder

Liberation larder is a Byron Bay based volunteer run organization that's mission is to help feed and sustain those in our community who find themselves without a home or in need of that extra bit of help to get by in what can be very financially trying times.

We do this by rescuing food from the many generous local businesses and individuals of our shire .The food is collected by a team of volunteers operating 7days a week. Mondays and Thursdays see more of our talented volunteers turn this rescued food into over 300 nutritious meals on each day as well as handouts of fresh produce and other donated grocery items.

All up last year our team of over 50 volunteers created over 30,000 meals plus grocery handouts from over 60,000 kg of rescued food and grocery items

We also donate food to Fletcher St Cottage, The Byron Youth Activities Centre, The Brunswick Heads Breakfast Service and other food distribution services when their needs arise. Liberation Larder does all this without any government funding relying solely upon the generosity of our local businesses and community members to keep us financially viable and I thank those that contribute to our cause with all my heart.

I would like to end my report with the greatest appreciation for our volunteers that if not for their dedication to the Liberation Larder Cause our all important contributions to the community would be non existent. All our vollies carry out their respective tasks with a great sense of "wanting to help those in need". The collectors rescuing food and groceries to the crew that work on the Monday and Thursday creating the amazing meals and those sorting and distributing the food and groceries as well as those who help clean up at the end of each day all done with an amazing level of efficiency at the same time with a smile and the feeling that "they want to be there." Not forgetting those team members who step up as coordinaters and committee members to give a guiding hand to our well oiled machine.

# **Management Committee Meetings**

During the year the Management Committee met on 6 Occasions:

### 29 August 2024

This meeting focused on, amongst other things, fiscal challenges and discipline, relations with the Fletcher Street Cottage, fund raising (trivia night), website update for 'Vollaby' program (online induction) and a volunteer's (Mark Smith) accident while collecting for the LL at Brookfarm.

### 24 October 2024

This meeting focused on, amongst other things, ensuring we, as much as possible, only use donated food for cooking, bequeathing to the LL, rejecting the 'Vollaby' proposal, encouraging better volunteer behaviour around parking and handing out food reserved for cooking, a discussion around a 'shop and share' idea for the markets, the end of year volunteer and client Xmas parties and a grievance raised by a volunteer.

At this meeting Ruth resigned as Secretary and David was appointed in her place.

#### 28 November 2024

This meeting focused on, amongst other things, resolution of the grievance raised at the last meeting, vouchers for women in need and reporting back to 'Darling Muffs of May', rejecting a request from the Byron Bay Community Centre (BBCC) for their branding on our website, drafting of the 4<sup>th</sup> edition of the LL newsletter, a discussion around engaging an operations manager and resourcing generally, festive season opening hours and security at the storage shed and at the LL kitchen and the need to improve BBCC volunteers behaviour around helping themselves to food, paying for meals and sticking to collection times.

# 23 January 2025

This meeting focused on, amongst other things, resolution of the website update, Mark's accident and progress with Brookfarm and its insurer, rejecting the idea of engaging an operations manager, improved security at the storage shed and the LL kitchen, improved behaviour by BBCC volunteers, rejecting involvement in 'Shake a Bucket' fundraising at the Byron markets due to historical 'little return' for too much effort, the need to update first aid and food safety training for volunteers. Finally, the Committee considered change of membership of the Committee as follows:

### The meeting:

- accepted Liz's resignation as President and from the Committee;
- accepted Jane's resignation from the Committee;
- confirmed John's appointment as President and Public Officer; and
- confirmed Lisa Carey's appointment to the Committee.

### 13 March 2025

This meeting focused on, amongst other things, the lack of progress of Mark's claim with Brookfarm's insurer and the need to take private legal action, rejection of the 'shop and share' idea as it is deemed too labour intensive for a potential low return, the fact that a number of volunteers will be attending the BBCC's first aid training course, change of signatories for the LL's account with the Southern Cross Credit Union, moving funds into a new term deposit, insurance renewal – awaiting final proposal from our broker AON, moving all food items from the storage shed to the kitchen, security protocols regarding client misbehaviour and eligibly to be LL clients.

### 6 May 2025

This meeting focused on, amongst other things, finalisation of Bequeathing wording for the website, an update on Mark's claim, completion of first aid and food handling training, renewal of LL's insurance, grant applications and the future vision for the LL.

# All meetings

At each meeting held during the financial year the Committee confirmed quorum, reviewed the minutes of the previous meeting and any action items arising therefrom. It also reviewed and discussed the most recent financial statements provided by the Treasurer and on each occasion formed the view that the LL is financially sound and agreed that the LL had not incurred debts which are not expected to be repaid.

### In Conclusion

The Committee and the LL, in a challenging year, which has seen increased demand on our services due to increased homelessness and cost of living pressures, has operated effectively in compliance with all statutory and regulatory requirements and also in accordance with its mission statement.

# **Treasurer's Report**

My job is to provide a clear overview of Liberation Larder's financial statements over the period of 01/07/2024 throughout 30/06/2025. The report is essential for transparency and accountability, allowing the members to understand the financial position and make informed decisions.

In this financial year, we served 13,564 clients. But more than the number of people, it was the way we showed up weekly, completing our missions for the people who needed us and building something just as meaningful with our community.

We also have daily collectors to pick up, bakeries, restaurant and supermarket surplus food & produce. It really does feel great to know this food has been rescued, reducing landfill and then as the double bonus it is used to feed people who can't afford nutritional food.

That is part of what has made it incredible, being a part of the Larder big family, and as a member of the board for 10 years, I am deeply grateful for the privilege of standing alongside you all.

I extend my great appreciation to you, the volunteers who have spent the time (estimated at 13,832 hours) collecting from supermarkets, bakeries and other pick-ups, also the cooking, packing, preparation, serving, cleaning up and administration. Your dedication, warm hearts, and the unity I have witnessed is beyond anything I could have imagined.

As a legal requirement, we need to provide a Not For Proffit (NFP) statement as LL is registered with the Australian Charities and NFP Commission (ACNC) each year within five months of the financial year-end.

Donors, board members, government agencies, and potential finance donors rely on the NFP statement to assess our organisation's financial health, governance practices, and overall performance. It is not just crucial for compliance, it also helps build trust and accountability, which are essential for attracting funding and support.

Page 3 - the "Reviewer" looked through our in-depth accounting information in order to ensure that the reporting was a true representation of our organisation's financial position. This can help assess any risk. They can also help board members spot potential internal oversights or unethical behaviour.

1) **Page 11** - the Statement of financial activities (aka profit & loss statement in a company), shows the year revenue and spending and how those expenses relate to the work of carrying out our operational activities.

# Note: list on Page 18, 19 & 20 as a nonprofit organisation, revenue also include non-cash gifts, in-kind donations of goods and/or services

While our goal as a non-for-profit charity organisation is not to turn a profit, we should retain an appropriate level of money reserve "Surplus" as it helps us to survive during slow fundraising years or unexpected expenses, and to maintain financial stability to carry out operational plans. We make it clear to the donors & funders, that any surplus will be (and must be) used in the pursuit of the purpose of our charity.

### The Financial Position -

A simple way to look at it is: total Assets = total Liabilities + total Equity. The most relevant part for us is the total money at the bank. That is \$144,800.08 at the bank as at 30/06/2025.

Current Liabilities -- GST \$-665.00 as at Q4 FY2025

Current year surplus -- our net surplus \$35,089.03 in FY2025 (01/07/2024 – 30/06/2025) as shown as Statement of Activities.

Opening balance equity -- \$71,497.36 is an account created an opening balance carried over since July 2018 with QuickBook accounting system.

Retained Surplus -- \$38,878.69 is a retained revenue represents the sum of all Financial Years surpluses or deficits.

As a non-for-profit organisation, no one person owns the retained and accumulated reserves \$144,800.08. It shows the organisation's financial health and it has been saved over time and is available to pay any bills.

### Notes to the financial statements

# 1. Reporting Entity

Liberation Larder Inc. is domiciled in Australia, with the registered office at 4/47 Jonson Street, Byron Bay and the kitchen operates at the back of Byron Community Centre (69 Johson Street Byron Bay).

NSW Fair Trading does NOT require an audit of Tier 2 (small) associations have total revenue of less than \$250,000 and current assets less than \$500,000 association's financial statements. As a small charity, Liberation Larder Inc, has obtained an independent reviewed Annual Financial Report, as it is optional, but encouraged.

From 1 October 2018, Liberation Larder Inc became registered with the Australian Charities and Not-for-profits Commission (ACNC), and then required to submit the annual financial reports to the ACNC. The ACNC will share the information with NSW Fair Trading.

Liberation Larder Inc provided monthly financial statements for the committee, and its annual financial report prior to the 2025 AGM for an independent review to check the transaction accounts, bank statements, Statement of Activities and Financial Position.

# 2. Basis of Accounting

The accounting system is based on cash. The main sources of revenue are donations from organisations, individual, business, and Mondays & Thursdays lunch services. The main expenses are: food ingredients, takeaway containers and other packaging, kitchen cleaning, small kitchen supplies, repairs and maintenance, office expenses such as stationery and accounting service. More details are shown in the Statement of Activities.

These financial statements are for the Liberation Larder Inc and have been prepared in accordance with the bank statement, supplier's invoices, and shop receipts, compiled exclusively for the benefit of the committee who is responsible for the reliability, accuracy and completeness of the information used to compile them. Accordingly, these financial statements may not be suitable for other purposes. We do not accept responsibility for the contents of these financial statements.

# 3. Statement of Significant Accounting Policies

This financial report has been prepared specifically for Liberation Larder Inc in order to satisfy the financial reporting requirements of the Associations Incorporation Act 2009.

No Australian Accounting Standards or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

The financial report is prepared on a cash basis and ongoing concern basis from the records of Liberation Larder Inc. It is based on historical costs and does not consider changing money values.

### 4. Income Tax

Liberation Larder Inc is exempt from income tax under Division 50-50 and 50-52 of the Income Tax Assessment Act 1997.

Liberation Larder Incorporated is a Public Benevolent Institution endorsed to access the following tax concessions: GST Concession; Income Tax Exemption and FBT Exemption

# 5. Provision for Gift Deductibility

Liberation Larder Inc is endorsed as a Deductible Gift Recipient (DGR) from 01 Jul 2012. It is covered by Item 1 of the table in section 30-15 of the Income Tax Assessment Act 1997

### 6. GST Concession

Liberation Larder Inc is GST registered with ATO since July 2018 and comply with:

- **Gifts and GST credit adjustments** adjustments for GST credits are not required where an item acquired by a business is subsequently gifted to the charity.
- Accounting on a cash basis the charity may choose to account on a cash basis regardless of its annual turnover.
- Raffles and bingo tickets to raffles and bingo sold by the charity are GST-free provided the holding of the raffle or bingo event does not contravene a state or territory law.
- **Fundraising events** The charity is not required to remit GST on supplies made in connection with the event. However, the charity is entitled to claim GST credits for related purchases on goods and services.
